Respondent, John Koziara t/a Koziara Trucking & Excavating (Koziara), has paid in full the amount of the civil penalty agreed upon by the parties in order to resolve without litigation the above-docketed complaint. On or about August 28, 2013, the Commission received payment by company check in the amount of \$250, which was the monetary fine agreed upon between I&E and Koziara for the carrier's failure to schedule and pass a safety fitness review (SFR).

In addition, Koziara was directed to schedule a SFR. On October 18, 2013, I&E was advised that a SFR was conducted by the appropriate Commission staff on October 15, 2013 and that Koziara satisfactorily passed this SFR. Since Koziara has paid the fine and successfully completed its SFR, the terms of settlement have been met. Accordingly, pursuant to 52 Pa. Code Section 5.24(a), the Pennsylvania Public Utility Commission, Bureau of Investigation and Enforcement, files this letter to certify that the above-docketed proceeding has been satisfied and should be marked closed.
