Dear Lisa Barry:

We are pleased that Progressive Energy Consultants ("PEC") has applied for a license to provide Natural Gas Broker/Marketer Services on the distribution system of Columbia Gas of Pennsylvania, Inc. ("Columbia Gas").

Under Paragraph 2.4.5 of the Rules Applicable to Distribution Service section of the Tariff of Columbia Gas, PEC could be required to provide to Columbia Gas a bond or other financial security instrument in an amount that Columbia Gas determines to be appropriate. PEC has indicated only brokering and consulting services will be provided. Therefore, we have determined at this time that PEC does not need a bond or other financial security requirement to provide broker natural gas services to Columbia Gas customers.

If the creditworthiness requirement or Columbia Gas' exposure to PEC changes in the future, Columbia Gas might deem it appropriate to require PEC to provide a bond or other financial security instrument.



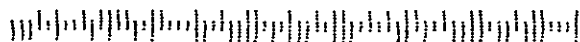

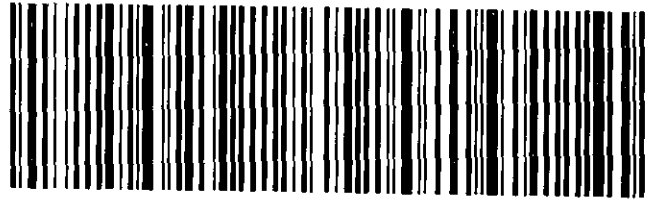
