I am writing this letter to "OPPOSE" the settlement agreement for wastewater flat rate billing.

Since there are only 64 customers in this area who are only wastewater customers, PAW continues to compare wastewater and water customers with their statements for billing.

PAW states:

- A. Typical residential water customers in Zone 1 using (3,960) gals. Of water.
- B. Typical residential wastewater customers with average usage (3,960).

I would like to know how PAW can compare the usage of a house that is NOT metered and one that is. Also, not knowing how many people live there. I am a single person, and I wonder how many of the 64 wastewater customers in this area are also single and paying the same amount as a house with three (3) or more living there.

PAW needs a **sliding scale** for flat rate customers according to how many people live in the house. PAW has the ability to **MODIFY** these charges according to their TARIFF ORIGINAL PAGE No 6A item No 11 (EDU). Why IS PAW not making a change so their charges are FAIR TO ALL?

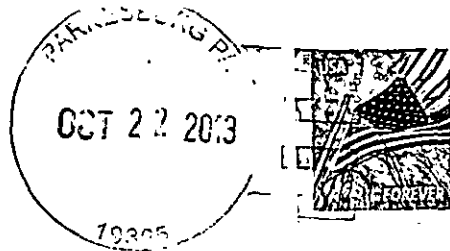
