

Pursuant to the *Commission's Interim Guidelines Regarding Notification by an Electric Generation Supplier of Operational Changes Affecting Customer Service and Contracts* (Docket No. M-00960890F0013, please accept this joint letter as notice by Castlebridge Energy Group, (Electric Generation Supplier License No. A-2011-2235118) ("Castlebridge"), and Washington Gas Energy Services (Electric Generation Supplier License No. A-110158) ("WGES"), that Castlebridge will assign certain of its customer contracts to WGES. Castlebridge does not intend to cease operations.

Castlebridge and WGES request "CONFIDENTIAL" treatment of this filing, as it contains proprietary information that the companies do not disclose in any financial reporting.

The assignment will take effect on or about December 2, 2013, and WGES will begin serving Castlebridge's Pennsylvania customers at that time.

The assignment transaction will be seamless for customers. WGES will assume Castlebridge's contracts as they stand. Accordingly, customers will experience no change in price for the duration of their contracts, nor will they experience a change in terms and conditions.




As required by the aforementioned *Interim Guidelines*, Castlebridge and WGES have sent the enclosed materials to customers to notify them of the upcoming transition of their accounts. The materials include a joint letter to customers from Castlebridge and WGES, and a timeline of what customers can expect to happen next. Additionally, the materials include a buckslip with more information about WGES.

Castlebridge and WGES customer service agents have been trained to talk to customers as the transition occurs, and to explain what the transition means for the customers. Additionally, customers will be directed to a dedicated website - www.wges.com/CEG - that will provide customers with more information about the transition.

Castlebridge and WGES are confident that this assignment transaction will be seamless for customers. The companies respectfully request that the Commission note the transaction, and the companies will continue to notify the Commission of any changes.
