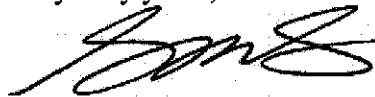

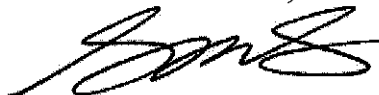
has provided Complainant with the telephone number for the LIHEAP customer assistance program.

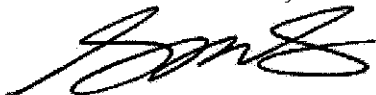
