



 - (a) Complainant, Barbara Manning, and Respondent, PPL Electric, agree that Complainant will pay her current monthly budget bill in the amount of \$57.00 by November 22, 2013. Complaint and Respondent further agree that Complainant will pay her regular monthly budget bill plus \$64.00 per month toward arrearages, until all arrearages are paid in full, beginning with Complainant's December due date.
 - (b) Complainant agrees to withdraw her Complaint.
