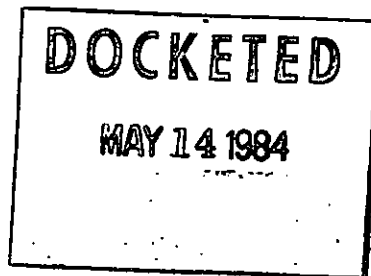

Kindly attach the enclosures to the compliance order previously issued and mailed to you on March 26, 1984.

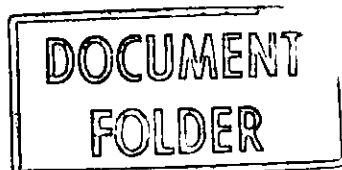


