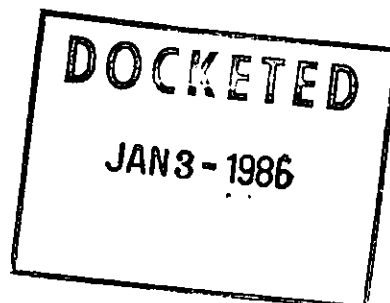

We are in receipt of a December 18 letter from your office indicating that your records show that J. F. Lomma, Inc. has not complied with the tariff/insurance requirements imposed by a compliance Order entered October 8, 1985.

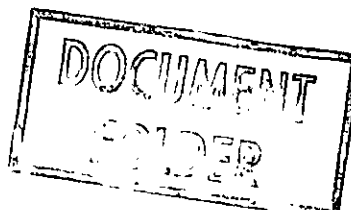
