Aqua Pennsylvania, Inc. (Aqua) respectfully requests that the scheduled Initial Hearing on November 21, 2013 in the above-referenced proceeding be converted into a Prehearing Conference.

Aqua has unsuccessfully attempted to contact Bonnie Asbouriam (Complainant) on several occasions and by several methods (phone and letter) to discuss her Formal Complaint. Today Aqua was made aware of the fact that the Service Location¹ has been foreclosed by the mortgage holder, Bank of America and a Sheriff Sale has been scheduled. Given this development, Aqua seeks to determine the status of the ownership of the Service Location and the impact, if any, to the pending complaint proceeding. I have enclosed the Delaware County Court docket entries for the Service Location. The Writ of Execution was entered on November 4, 2013.

Please note that the service is on at the Service Location and the current tenants are paying the monthly charges associated with the water service.
