Dear Sir:

Your attention is directed to a letter from the Commission dated November 30, 1983 together with the compliance order of the Commission, notifying you of the Commission's approval of the application for a certificate of public convenience in the above entitled proceeding, limited and restricted to certain definite rights.

The letter states that the applicant would be required to file with the Commission within sixty days (60) of the date of the letter a certificate of insurance or other security and a tariff of its rates and charges that the certificate of public convenience authorizing actual operations would not be issued until the compliance with these requirements.

Motor carriers operating without complying with these requirements and hence without a certificate of public convenience are operating illegally and subject to the penalty provisions of the Public Utility Law.

Our records show that you have failed to comply with the insurance requirement(s). Unless the requirement(s) is complied with immediately, the Commission will rescind the action of November 30, 1983 approving the application and dismiss it without further proceeding.
