## Re: Application of BOC Energy Services, Inc., for approval to offer, render, furnish, or supply electricity or electric generation services as a broker/marketer engaged in the business of supplying electricity in the Commonwealth of Pennsylvania; Docket No. A-110162

Dear Secretary McNulty:

On October 6, 2004, BOC Energy Services, Inc., filed an Application for an Electric Generation Supplier ("EGS") License as captioned above, seeking to provide service beginning no later than January 1, 2005. By this Filing, BOC Energy Services, Inc., supplements its October 6 Application with an original and eight copies of the following:

- 1) BOC Energy Services, Inc.'s processed and signed Application for Certificate of Authority. Please include this as Exhibit A to the Application.
- 2) A copy of Barclays Bank PLC's ("Barclays") Letter of Credit, issued on behalf of BOC Energy Services, Inc., on October 8, 2004. Barclays sent the original Letter of Credit directly to the Commission. Please include the Letter of Credit as Exhibit E to the Application.

By this Filing, BOC Energy Services, Inc., supplements its October 6 Application with its processed and signed Application for Certificate of Authority.<sup>1</sup> Please include the attachment as Exhibit A to the Application.

Also in the EGS Application, BOC Energy Services, Inc., included a draft of its Letter of Credit, which was in the process of being issued by Barclays. Barclays issued the Letter of Credit directly to the Commission on October 8, 2004. To ensure its EGS Application is complete, however, BOC Energy Services, Inc., herewith files a copy of the Letter of Credit.
