Dear Judge Johnson:

Enclosed on behalf of Duquesne Light Company (“Duquesne Light” or the “Company”) are Errata Sheets to certain of the Rebuttal Testimony and Exhibits filed by the Company on November 26, 2013. The Errata Sheets are being filed to correct the present rate revenues calculated in Duquesne Light Statement No. 3-R and accompanying Exhibits and the resulting revenue requirement set forth in Duquesne Light Statement 5-R and accompanying Exhibits. The correction to present rate revenues is related to a correction in the number of HVPS customers as reflected in Exhibit JH 1-R. This decreases the Company’s overall revenue requirement increase as presented in its Rebuttal Testimony from \$72,922,000 to \$72,732,000.



The revisions to the revenue requirement will have an insignificant impact on the Company's Cost of Service Study ("COSS") and Revenue Allocation that also were filed on November 26, 2013. Because the impact of the changes to the COSS and Revenue Allocation would essentially be lost in the rounding, Duquesne Light is not filing Errata Sheets for these documents.
