RESOLUTION OF DALTON BOROUGH COUNCIL AUTHORIZING DALTON BOROUGH COUNCIL PRESIDENT AND OTHER APPROPRIATE OFFICIALS OF THE BOROUGH OF DALTON TO EXECUTE AND ENTER INTO A RIGHT- OF- WAY AGREEMENT WITH PPL ELECTRIC UTILITIES CORPORATION.

WHEREAS, PPL Electric Utilities Corporation has advised Dalton Borough that it is in the process of replacing the electrical wires along Fuller Road, and in doing so needs to ensure that PPL will be able to keep the trees along Fuller Road from interfering with the electrical wires; and,

WHEREAS, PPL ELECTRIC UTILITIES CORPORATION has proposed that Dalton Borough execute and enter into a Right-of-Way Agreement, a copy of which is appended to this Resolution as Exhibit A and incorporated herein by reference.

NOW, THEREFORE, be it resolved by the Council of the Borough of Dalton that Dalton Borough Council President, William Salva, and other appropriate officials of the Borough of Dalton are authorized to execute and enter into the Right-of-Way Agreement with PPL Electric Utilities Corporation.

Section 1. This Resolution shall become effective immediately upon passage.

Section 2. This Resolution is enacted by the Borough of Dalton under the authority of the Act of Legislature, February 1, 1966, P.L. (1965) No. 581 Sec. 1005, as amended 1979, November 2, P.L. 458 No. 94, 53 P.S. Sec. 46005, et seq., known as the Borough Code and any other applicable law arising under the laws of the Commonwealth of Pennsylvania.

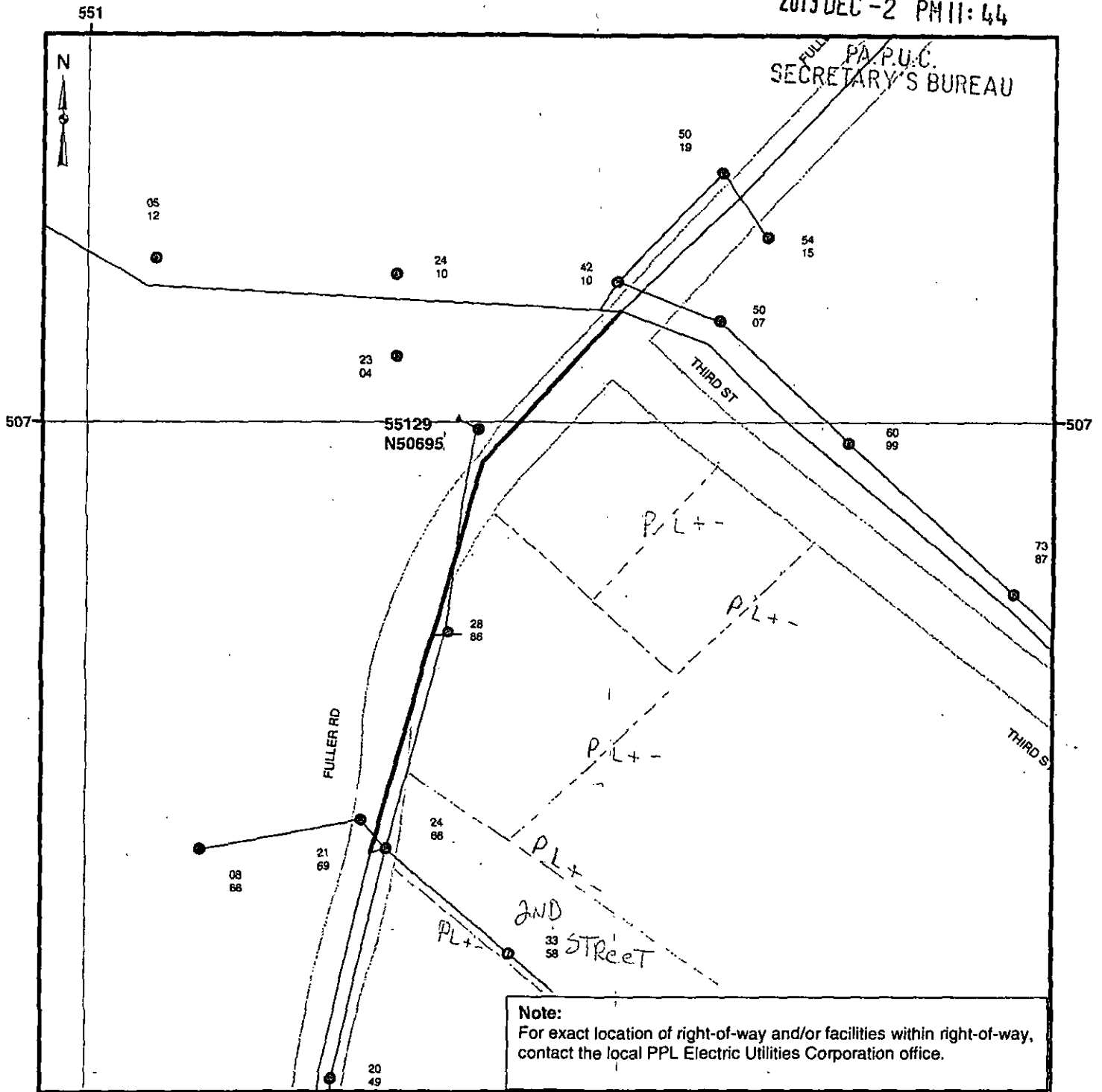

RIGHT-OF-WAY AGREEMENT FOR TREE WORK
Municipal Authority

KNOW ALL MEN BY THESE PRESENTS, that Dalton Borough, a municipality of the Commonwealth of Pennsylvania, hereinafter called "GRANTOR", intending to be legally bound, does hereby for itself and its successors and assigns grant unto **PPL Electric Utilities Corporation**, hereinafter called "GRANTEE", its successors, assigns and lessees, the right, privilege and authority to cut down any and all trees within fifteen feet (15) feet each side of centerline of the electric line and the right to trim any and all trees within fifteen (15) feet each side of centerline of the electric line and to remove brush along said lines which in the judgment of the said Company menace the said lines; located on the property which the undersigned owns or has any interest located along Fuller Street, situate in the Borough of Dalton, County of Lackawanna, Commonwealth of Pennsylvania.

A copy of this agreement and an acceptance hereof by PPL shall be filed by PPL with the Pennsylvania Public Utility Commission and this agreement shall thereafter become effective in accordance with the provisions of the Public Utility Law.
