Rezman Express filed the 2011 and 2012 Assessment Reports (Attached Copies for your records). Today I called the Compliance Office and I explained to Mr. Robert Bangaman that we did not abandoned or discontinue services for Limousine or Buses in PA, we are in business in PA at our Branch in 211 N. Governor Printz Blvd Essington PA 19029 and our Headquarters is located at 800 Cedar Lane in Teaneck NJ 07666. We filed the reports with the Intrastate Revenue for the years 2011 and 2012 and Mr. Bangaman explained to us that they received the reports but that the reports were not showing any revenue for Limousines, at that moment we realized our mistake at filing the report we entered all the Revenue for buses and limousines together on the box for Group and party 16 or more and we didn't realize that it is two boxes one for PASSENGER -Group and Party 16 or more and Other box for Passenger 15 and under. We will be more careful filing the report for 2013 that we didn't receive it yet and we will present it as always before March 31,2014.

Also last week on November 10,2013 we mailed to PUC the new updated list of vehicles since we replaced and added more vehicles to our fleet (Attached list of vehicles). Rezman Express holds an active Authority in PA with the Commission; we would like to please review all paperwork provided to lift any revocation of our Certificate of Public Convenience for Limousine Service since we needed to conduct our Business.
