**MOTION OF COMMISSIONER GLADYS M. BROWN**

In 2000, Tiger Natural Gas Inc. (Tiger or Company) was conditionally granted a license to provide natural gas supplier (NGS) services to large commercial, industrial, and governmental customers in numerous natural gas distribution company (NGDC) territories. Tiger's license was conditioned upon the Company filing with the Commission proof of compliance with the security requirements for the eight individual NGDC territories where it sought to operate.

On June 26, 2013, Tiger filed an Application to amend its NGS license. Specifically, Tiger seeks authority to offer NGS services to residential and small commercial customers in the service territory of Columbia Gas of Pennsylvania Inc. (Columbia). To date, Tiger has only provided proof of compliance with the security requirements for Columbia.

I agree that Tiger should be allowed to expand its operations in Columbia's territory since it has complied with all necessary requirements for this expansion.

However, I believe it is necessary to direct Tiger to file proof of compliance with the security requirements for the remaining NGDC territories in which it was conditionally licensed to operate. If the Company fails to file the necessary proof of compliance, its license shall be amended to remove its authority to operate in territories for which it has not provided the required security documentation.

**THEREFORE, I MOVE THAT:**

1. Tiger Natural Gas Inc. is directed to provide documentation, within 90 days of the entry date of this Order, evidencing proof of compliance with the security requirements for the following natural gas distribution companies in whose territories the Company was conditionally licensed to operate in the Commission's June 2, 2000 Order: Peoples Natural Gas Company LLC, UGI Penn Natural Gas (formerly PG Energy), PECO Energy Co., UGI Utilities Inc., UGI Central Penn (formerly PFG Inc.), Equitable Gas Company, LLC<sup>1</sup>, and National Fuel Gas Distribution Corporation.

<sup>1</sup> The Commission has approved a merger between Equitable Gas Company, LLC and Peoples Natural Gas Company LLC in its Order entered November 14, 2013 at Docket Nos A-2013-2353647, A-2013-2353649, and A-2013-2353651.

2. Tiger Natural Gas Inc. is advised that if it does not provide such documentation its license shall be amended to appropriately reflect the natural gas distribution company territories for which the Company has provided security documentation.
3. That the Commission's Bureau of Technical Utility Services prepare an Order consistent with this Motion.
