



**CERTIFICATE OF SATISFACTION**

1. Complainant is Cynthia Lynch.
2. Respondent is PPL Electric Utilities Corporation (hereafter referred to as "PPL Electric").

3. This Certificate of Satisfaction of Complaint is submitted pursuant to 52 Pa. Code § 5.24(b).

PPL Electric hereby certifies that the parties to the above-referenced formal Complaint, now pending before the Pennsylvania Public Utility Commission (hereafter "Commission"), have mutually and voluntarily agreed upon the following terms as full satisfaction of all outstanding legal and factual disputes in this proceeding, and Complainant has acknowledged satisfaction to PPL Electric:

(a) Complainant, Cynthia Lynch, and Respondent, PPL Electric, agree that Complainant's budget bill amount will be reduced from \$134.00 to \$129.00 per month. Complainant and Respondent further agree that Complainant will pay her regular monthly budget bill plus \$20.00 per month toward arrearages, until all arrearages are paid in full. Complainant and Respondent further agree that Complainant's first monthly payment of \$149.00 will be due on December 28, 2013.

(b) Complainant agrees to withdraw her Complaint.

5. Respondent, PPL Electric hereby notifies Complainant of the filing of this Certificate of Satisfaction, and that if Complainant objects or disagrees with the terms of the Certificate of Satisfaction, Complainant must notify the Commission in writing of their objection and/or disagreement within ten (10) days of the date this Certificate of Satisfaction was signed and served, or the terms of the Certificate of Satisfaction will become final and binding.
