

Please find attached a revised Page 6 of the application for a natural gas broker license, revised to once more expand the list of gas utility territories we propose to offer services in;


We are still waiting for several of the bonding letters from various utilities. I will forward the letters as I receive them.

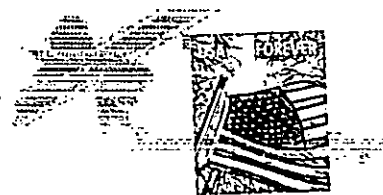
