
- Citizens' Electric Company

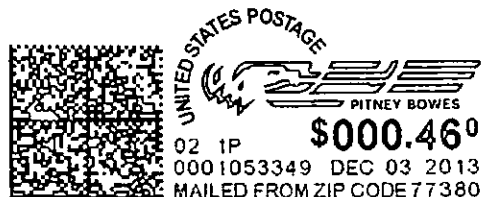
