

Complainant and Respondent further agree that Complainant will subsequently pay her regular monthly bill plus \$27.00 per month toward arrearages, until all arrearages are paid in full, beginning with Complainant's January 2014 due


date. Complainant and Respondent further agree that Respondent will mail to Complainant an application for the OnTrack customer assistance program.

(b) Complainant agrees to withdraw her Complaint.
