**RESPONDENT'S PETITION FOR EXTENSION OF TIME
TO FILE EXCEPTIONS**

NOW COMES, the Respondent, Frontier Communications Commonwealth Telephone Company ("Respondent"), by and through its attorney, Andrew J. Katsock, III, Esquire, and hereby files a Petition for Extension of Time to File Exceptions in the above-captioned matter, and in support of its Petition, Respondent avers as follows:


1. On November 15, 2013, the Honorable Elizabeth H. Barnes, Administrative Law Judge, entered an Initial Decision in the above-captioned matter.
2. On December 3, 2013, a Notice was issued by the Pennsylvania Public Utility Commission providing that Exceptions to Judge Barnes' Initial Decision must be filed within twenty (20) days of the date of said Notice.
3. In accordance with said Notice, the deadline to file Exceptions to Judge Barnes' Initial Decision is December 23, 2013.
4. Respondent requests an additional thirty (30) days from December 23, 2013 to file Exceptions to Judge Barnes' Initial Decision.
5. Respondent requires the transcript of the hearing held on September 10, 2013 in order to prepare and file its Exceptions.

6. Respondent's undersigned counsel contacted the Complainant, Brian D. Sluzevich, asking for his concurrence with Respondent's requested extension of time.

7. Mr. Sluzevich concurred with Respondent's requested extension of time to file Exceptions.

WHEREFORE, the Respondent, Frontier Communications Commonwealth Telephone Company, respectfully requests that the Pennsylvania Public Utility Commission grant Respondent's Petition for Extension of Time to File Exceptions, and grant the Respondent thirty (30) days from December 23, 2013 to file its Exceptions.
