
MOTION TO ACCEPT E-FILING NUNC PRO TUNC

1. This is an application proceeding initiated by Danuch, LLC, seeking limousine authority.
2. Movants e-filed protests on January 2, 2014. See attached receipt.
3. Protests were due on December 23, 2013.


