At this time, it is anticipated that Frontier Commonwealth will request a \$1.67 increase to existing residential and business dial-tone rates on February 1, 2014.





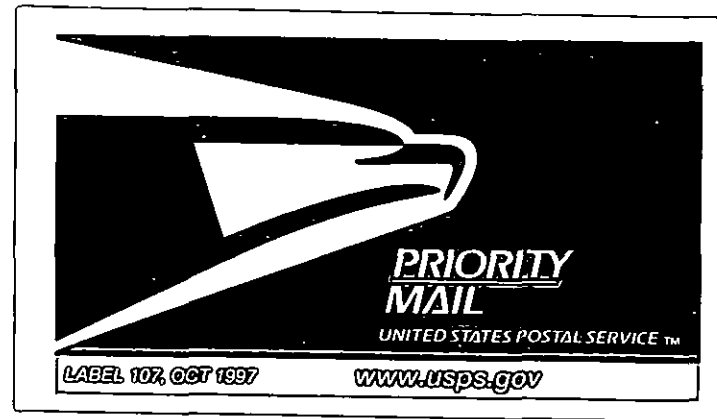
