**MOTION FOR CONTINUANCE**


Motion is hereby made that the Public Utility Commission pursuant to PA Code, Title 52 Chapter 5, Formal Proceedings, that the Commission Grant the Motion of the Complainant Daniel Vermeychuk for the following reasons:

1. Complainant certifies that no utilities are being used by any account in this matter and that all the accounts in this matter are non active accounts.
2. The Public Utility Commission has scheduled a hearing on this matter on January 28, 2014 and Complainant Daniel Vermeychuk is requesting a continuance for the following reasons.
3. Complainant Daniel Vermeychuk served Respondent PECO Energy on January 8, 2014, with an extensive request for Production of Documents and Interrogatories to be answered within 30 days and filed a copy of that request with the Secretary of the Public Utility Commission..

4. The 30 day period for answering the requests exceeds the January 28, 2014 date.
5. This action is in excess of \$50,000 with the only documentation provided to the Complainant are three pages of computerized number reports without any other documentation or support.
6. Complainant has a duty to prove this case and cannot proceed without further documentation.
7. Many, most or all of these accounts are in excess of four years old and some of them in excess of eight years old and the Respondent has not documented anything except a computer readout in an attempt to start the action but the Complainant realizes that once the hearing starts there is going to be all kinds of documentation produced without the chance to be examined and. or analyzed.
8. The Complainant requires a reasonable amount of time to receive this data and pull the available records and prepare the case for trial.
9. Complainant cannot prepare for hearing in this matter with the time constraints given.
10. Complainant must analyze the Discovery, prepare that information with any records available, prepare the matter for hearing, have time to settle the matter either through negotiation or mediation by the Public Utility Commission.
11. Complainant has already been to a Public Utility Commission hearing with this Respondent in which Discovery was served but the Respondent PECO Energy refused to allow Complainant to have its Discovery even though Respondent had the requested documentation at the hearing but the Respondent claimed that the 30 days wasn't up yet. Complainant's doesn't plan to make the same mistake twice.

12. Complainant, since all the accounts are non-active and all the accounts are four years old or older, requests a 90 day continuance in this matter to complete the Discovery, prepare the matter for trial and allow time for negotiations or settlement.
