At the hearing held in the above-referenced matter on December 10, 2013, Your Honor stated that the evidentiary record would be held open so that Peoples Natural Gas Company LLC ("Peoples") could submit a statement into the record that its acquisition of Equitable Gas Company LLC ("Equitable") had been consummated. Attached hereto as Appendix A is a copy of *Peoples/PTWP Statement No. 1-Supp. (Prepared Supplemental Testimony of Joseph A. Gregorini)*, which confirms the consummation of Peoples' acquisition of Equitable on December 17, 2013.

By this Letter Motion, filed pursuant to Section 5.103 of the Commission's Rules of Practice and Procedure, 52 Pa. Code § 5.103 (regarding "Motions"), Peoples respectfully requests that Peoples/PTWP Statement No. 1-Supp. be admitted into the evidentiary record and that the record thereafter be closed. Peoples has consulted with all other parties to this proceeding regarding this Letter Motion. The parties have all agreed to (i) waive any opportunity to file a response to this Letter Motion, (ii) waive cross-examination of Mr. Gregorini on Peoples/PTWP Statement No. 1-Supp., and (iii) not object to the grant of the relief requested herein.




