Dear Secretary Chiavetta:

On October 31, 2013, the Pennsylvania Public Utility Commission ("Commission") approved Guttman Energy, Inc.'s ("Guttman Energy") natural gas supplier license application at Docket No. A-2013-2374950. This approval licensed Guttman Energy to provide natural gas supplier services to commercial, industrial and governmental customers in the service territories of Peoples Natural Gas Company and Peoples TWP LLC. On January 9, 2014, the Commission approved Guttman Energy's amended gas application to provide natural gas supplier services to customers in the service territories of Columbia Gas of Pennsylvania, National Fuel Gas Distribution Corporation, Philadelphia Gas Works, and Equitable Gas Company, now Peoples Natural Gas Company—Equitable Division.

By this letter and amended filing, Guttman Energy hereby requests authorization to provide retail natural gas supplier services in the additional natural gas distribution company service territories of:

- PECO Gas
- UGI Central Penn Gas
- UGI Penn Natural Gas
- UGI Utilities, Inc.

Attached as Attachment 1 are letters indicating that Guttman Energy has satisfied the bonding or other financial security requirements of the four additional gas utilities. Attached as Attachment 2 is an updated application page 5 revising the list of natural gas distribution company service territories in which Guttman Energy proposes to provide retail natural gas

supplier services. Please note that Guttman Energy previously published notice of its natural gas application for all 10 service territories in all seven newspapers in the Commonwealth required for statewide authority. UGI Utilities, Inc. ("UGIU") has reviewed the financial information of Guttman Energy, INC. ("Guttman Energy"). Based on this review and the requirement that Guttman Energy must post security as specified in the UGI Gas ("UGI"), UGI Penn Natural Gas ("PNG") and/or UGI Central Penn Gas ("CPG") Supplier Coordination Tariffs before it serves customers on the UGI, PNG and/or CPG distribution systems, UGIU has determined that Guttman Energy has demonstrated adequate creditworthiness to satisfy any costs UGI, PNG and/or CPG may incur in the event they operate as a supplier of last resort due to a default on the part of Guttman Energy.

This determination may change in the event there is a material deterioration in that condition, if Guttman Energy's obligations to UGI, PNG and/or CPG exceed the amount of the financial security provided, if the financial security is withdrawn or is deemed to be null and void or inadequate due to the material financial deterioration of any guarantor, or if Guttman Energy fails to abide by the terms and conditions of the UGI, PNG and/or CPG Gas Tariffs and the UGI, PNG and/or CPG Natural Gas Supplier Coordination Tariffs.
