On Monday, July 10, 2006, WPS Resources Corporation and Peoples Energy Corporation announced an agreement to combine their operations, creating one of the Midwest's leading diversified energy companies. All necessary approvals were obtained and the transaction closed effective February 21, 2007.

The name of our ultimate parent has also changed from WPS Resources Corporation to Integrys Energy Group, Inc. This new name, Integrys (pronounced in-TEG-ris), was chosen to reflect our core value of integrity--integrity in our people, processes and systems. 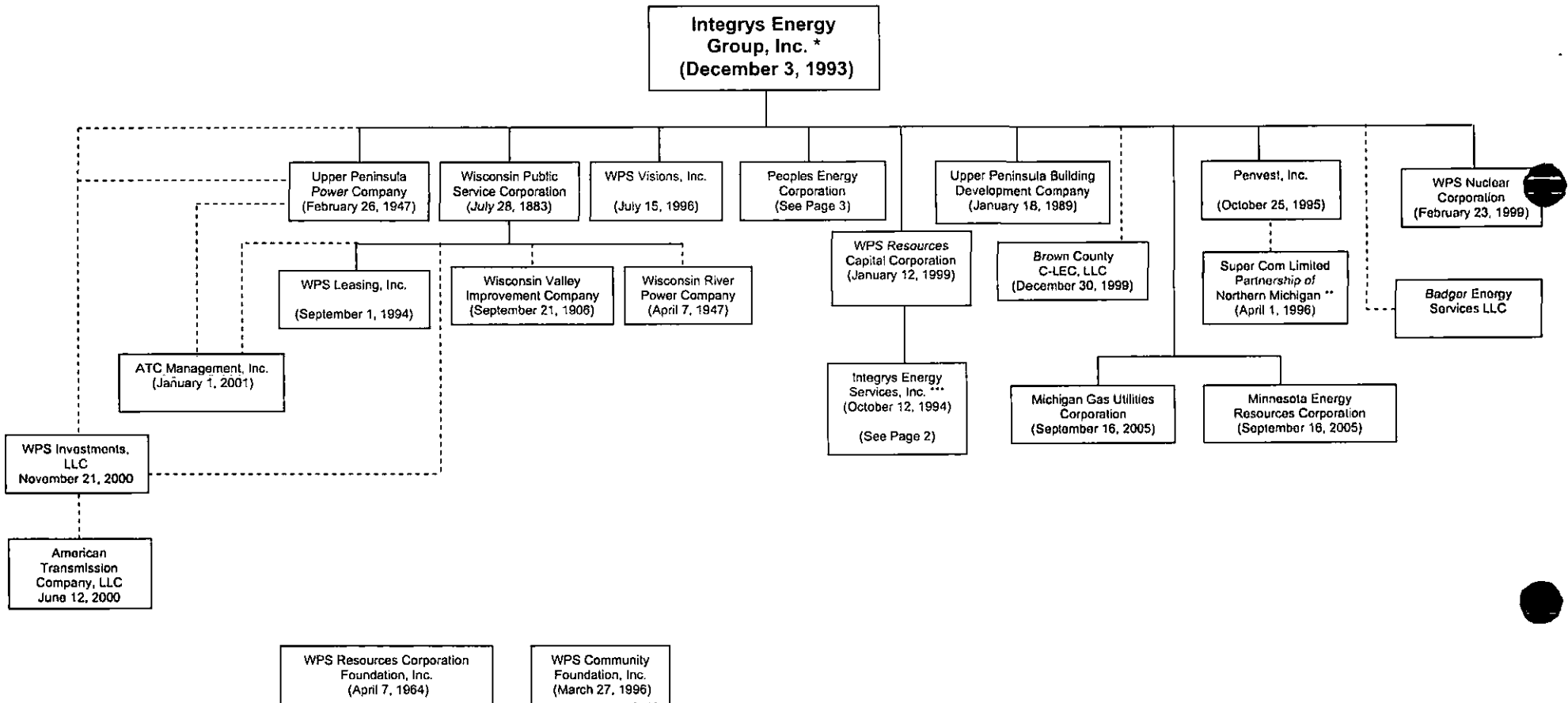

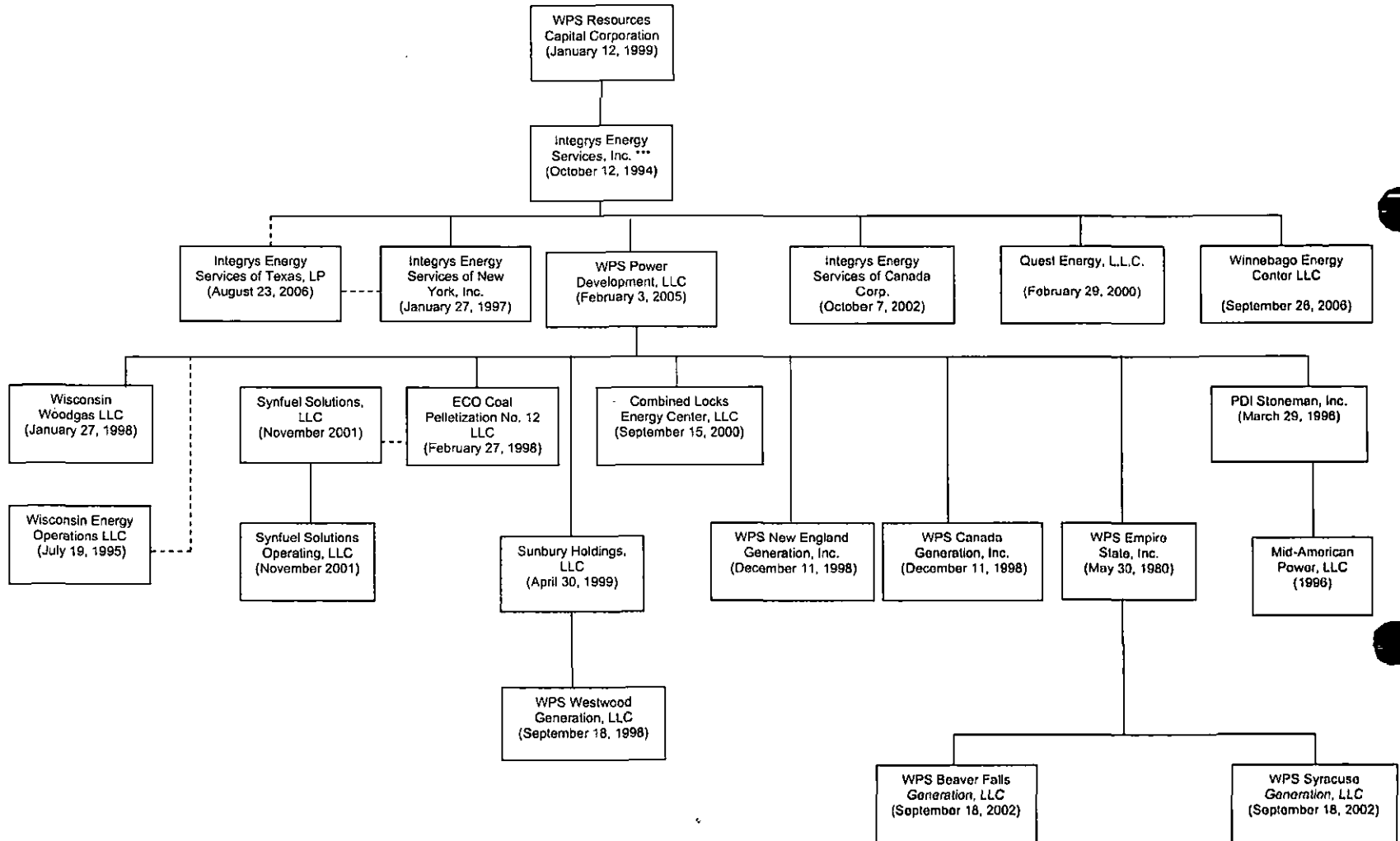
Integrys Energy Group, Inc. Organizational Chart
(as of February 27, 2007)



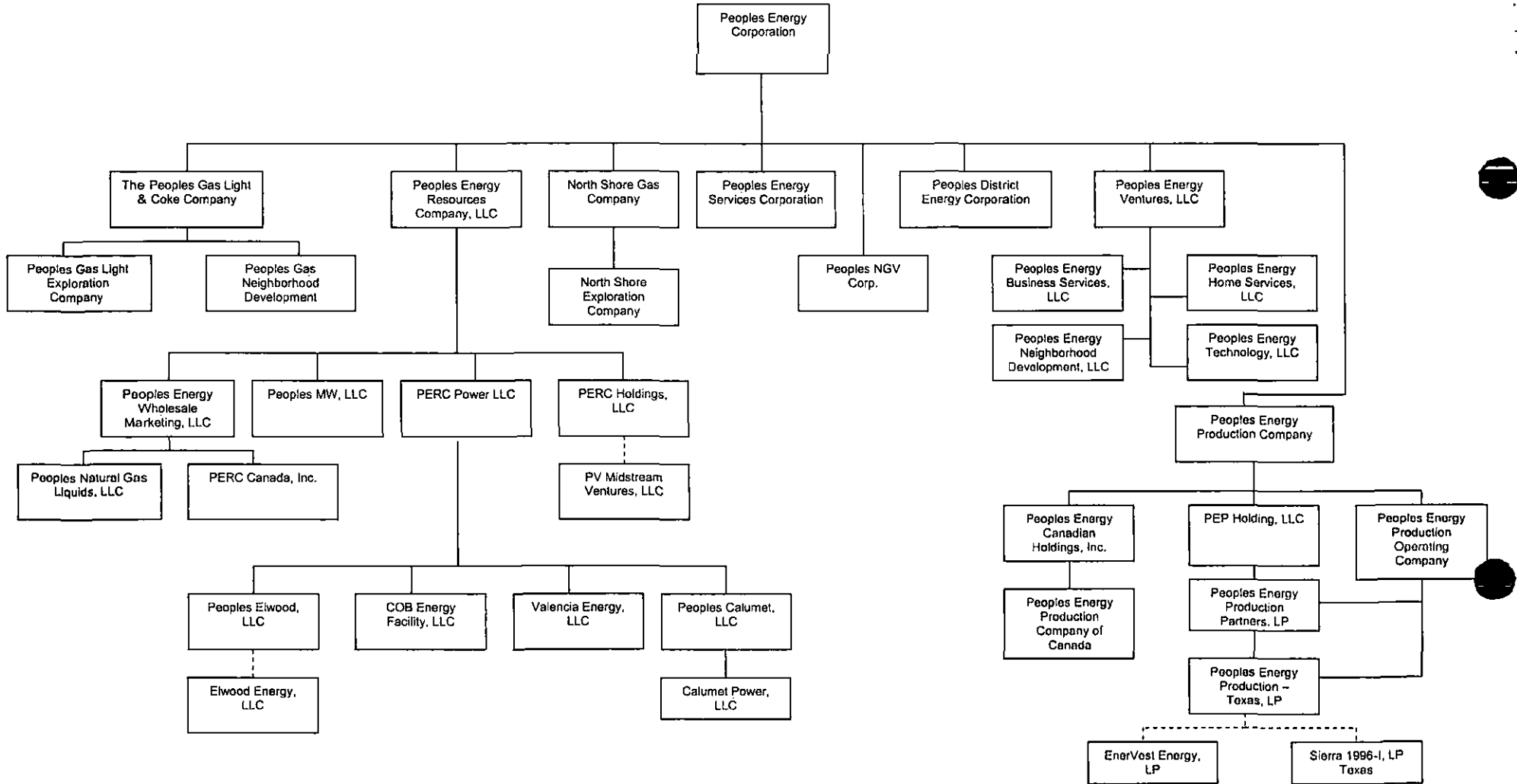
