
1. The name and address of applicant are **PPL Electric Utilities Corporation**, 2 North Ninth Street, Allentown, PA 18101-1179.
2. The name and address of applicant's attorney are **Paul E. Russell**, Associate General Counsel, **PPL Electric Utilities Corporation**, 2 North Ninth Street, Allentown, PA 18101-1179.
3. **PPL Electric Utilities Corporation (PPL)**, a Pennsylvania Public Utility offers electric utility service. PPL maintains a corporate charter in Pennsylvania, wherein the by-laws permit public utility companies to occupy public spaces, including said crossing.
4. PPL proposes to install and cross **State Route 590** with Three (3) 477 Aluminum XLP 7.2kv open wire primary, 1 4/0 ACSR neutral. See attached plan for specifications.
5. Affected parties: (See attached exhibit "A")
6. **State Route 590** is a two-lane bituminous asphalt roadway. Scope of proposed work is relatively minor in scope and construction time frame will be short in duration, a formal traffic study was not conducted. Appropriate traffic control will be employed in accordance with PennDOT highway requirements. Operating Railroad will be contacted to arrange for appropriate flagging/protection services.
7. The construction costs associated with this proposal would be approximately \$9,000.00.
8. The construction of said crossing, of the tracks of the **Stourbridge Railroad Company**, is necessary to install PPL Electric Utilities Corporation's overhead electrical system.

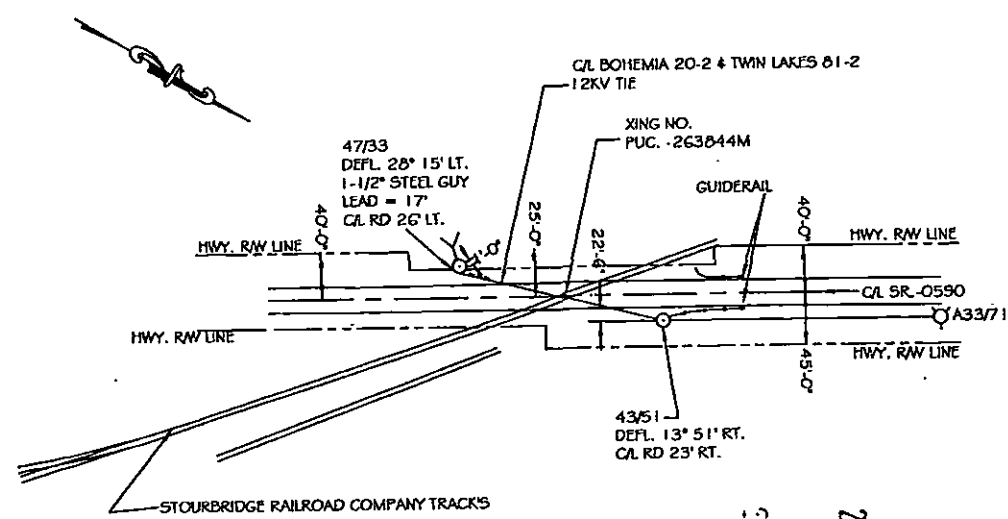
