

**CERTIFICATE OF SATISFACTION**


1. Complainant is August Spinicelli.

  - (a) Complainant, August Spinicelli, and Respondent, PPL Electric, agree that Complainant will pay his regular monthly budget bill plus \$15.00 per month toward arrearages, until all arrearages are paid in full, beginning with Complainant's March 2014 due date. Complainant and Respondent further agree that Complainant will be eligible to reapply for the OnTrack customer assistance program on June 6, 2014.

(b) Complainant agrees to withdraw his Complaint.


