On August 17th, 2012 my client Four Winds Trucking, LLC was granted operating authority under the PA PUC. After being granted operating authority by both the FMCSA and PA PUC, Four Winds Trucking, LLC was trying to get the company off the ground. After several attempts of not being able to get the company off the ground do to not being able to find loads for the equipment they had. Four Winds Trucking, LLC decided that it was in their best interested to shut down all their operating authorities. So on October 21st, 2013 Four Winds Trucking, LLC started the process of shutting down their operating authority. During the period of August 2012 to October 2013 Four Winds Trucking, LLC never transported any commodity at all. Since Four Winds Trucking, LLC never transported anything under PA PUC Authority or FMCSA authority they can't be held accounted for in regards to the complaint filed against them. 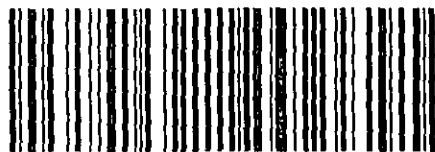
