Subject: Your Letter to Rosemary Chiavetta, Secretary, Pennsylvania Public Utility Commission, Re: Nathaniel Bracey v. PGW, Docket No. F-2014-2399842 dated January 28, 2014.

I am in receipt of your letter dated January 28, 2014 requesting "dismissal of complaint" filed by Me, Myself, I, Nathaniel James Bracey claiming that the legal fiction PHILADELPHIA GAS WORKS (sic) has erroneously and fraudulently placed a claim against Me, Myself, I, Nathaniel Bracey without an assessment and without proof that the charges of your unsubstantiated claim prior to June 2013 is applicable to Me. I am conditionally accepting your contract in that letter upon proof of claim that:

- (1) the Legal Fiction PHILADELPHIA GAS WORKS (sic) produce and/or submit lawfully accepted documentation showing that Me, Myself, I, Nathaniel James Bracey resided at a residence addressed as 5702 Overbrook Avenue prior to June 13, 2013, other than your (PHILADELPHIA GAS WORKS) unilateral and summary declaration, and
- (2) the monthly charges in the form of invoices that the Legal Fiction PHILADELPHIA GAS WORKS (sic) sends through the United States Postal Mail Service are not dividends but are in actuality payment to Me, Myself, I, Nathaniel Bracey, and to all other shareholders/customers with the PHILADELPHIA GAS WORKS, as a charged off debt PURSUANT TO:
73RD CONGRESS. SESS 1. CHS. 48 49. JUNE 5, 6, 1933 HJR 192
HR 1491 PUBLIC LAW 1 48 STAT 1
PUBLIC LAW 10 CHAPTER 48 STAT 112
PUBLIC LAW 73-10 40 STAT 411
TRADING WITH THE ENEMY ACT (TWEA) OCT 6, 1917
- (3) the Legal Fiction, PHILADELPHIA GAS WORKS (sic) is both the Supreme Court of the Commonwealth of Pennsylvania and a duly elected Judge/Arbiter thus having the authority to summarily and unilaterally dismiss any complaint/dispute over \$20.00 (twenty dollars) whereas, since the days of Independence of these United States of America every citizen protected under TITLE 8 U.S.C. 1324(b) of which the Living Man, Nathaniel Bracey is, has the right to have an impartial Arbiter arbitrate disputes over \$20.00.

Ms. Leva, you have thirty (30) days from receipt of this Conditional Acceptance to respond on a point-by-point basis, via sworn affidavit, under your full commercial liability, signing under penalty of perjury that the facts contained therein are true, correct, complete and not misleading. Mere declarations are an insufficient response. If an extension of time is needed to properly answer, please request it in writing. Failure to respond will be deemed agreement with the facts stated in the attached Affidavit and an inability to prove your claim, thereby indicating that the legal fiction PHILADELPHIA GAS WORKS, (sic) in law, does not have a claim against the Living Man, Nathaniel Bracey and does not have a lawful assessment to support any claim. This letter constitutes constructive notice to the recipient.
