I am writing on behalf of Williamsport Moving Co. – A-89650 and Keystone Relocation, LLC A-0121721 to protest an application for household goods authority as published in the PA Bulletin on January 24, 2014.


Our protest is based on there not being a need for additional service providers for intrastate or local household goods relocations in central Pennsylvania. The majority of our business occurs between June and September. The other eight months are a slow period and most of the movers in our part of Pennsylvania have too many trucks and too many idle crews waiting for work. For our industry to continue to make the investment in men and equipment we must somehow control the entry of new service providers unless there is demonstrated demand for the additional capacity.

We ask that the PA PUC Commission rule against this application unless the applicant can prove the need for an additional carrier.
