I received the certified mail February 4th, 2014. T/A Fagan Trucking had changed the business name to Fagan Trucking Inc. in January 2012 (see attachment A & B). Officially running under Fagan Trucking Inc. on 2Q 2012. I sent the letter informing your office to change the business name asking for a new PA PUC Certificate in January 2013 (See C & D) but before I received a new certificate, we had ceased operations on the last day of February 2013. We sent an email to Casey Gerlach, an Agent with Aggressive Insurance Services (E), to cancel all Liability and collision coverage. Since first day of March 2013, Fagan Trucking Inc. was no longer in business. My apologies for not sending a letter I was unaware that I had to. I respectfully request that you waive the fine against me.

Back in 2011 when we are running under T/A FAGAN TRUCKING, when we passed the first DOT Audit, PA PUC didn't conduct the second audit because they were satisfied with the DOT audit result. Your office asked to surrender and return our PA PUC Certificate we complied and mailed the certificate but we never receive the new PA PUC certificate

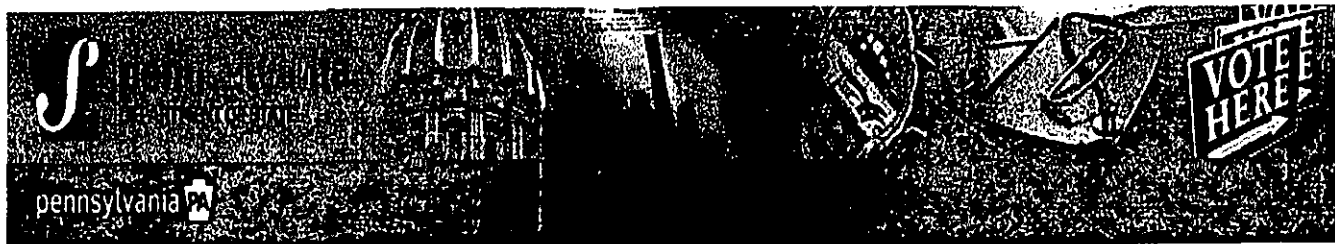

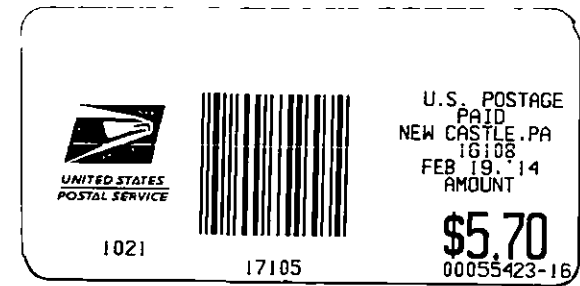
