Dear Secretary Chiavetta:

This letter is intended to update the Pennsylvania Public Utility Commission ("Commission") and Complainant Scott Klemas on the status of the above-referenced matter. For the reasons explained below, PPL Electric Utilities Corporation ("PPL Electric") respectfully requests that the Complaint continue to be deferred and held in abeyance until such time as PPL Electric submits an appropriate filing to the Commission regarding the proposed transmission line project at issue in the Complaint.

PPL Electric was served with the above-referenced Complaint by a Secretarial Letter dated April 27, 2012. The Complaint raises issues related to the siting and route selection of the North Lancaster-Honey Brook 138/69 kV transmission line that PPL Electric proposes to construct in the future.

On June 4, 2012, PPL Electric filed a motion requesting that the Complaint be held in abeyance pending the submission by PPL Electric of an appropriate filing seeking approval of the siting and construction of the transmission line so that the two related proceedings can be consolidated and considered together, and so that the proceedings can be adjudicated in an efficient manner on a complete record and with consistent results.

The North Lancaster-Honey Brook 138/69 kV transmission line is still in the planning stage and has not yet been submitted to the Commission for review and approval. At this time, PPL

Electric anticipates submitting an appropriate filing seeking approval of the siting and construction of the North Lancaster-Honey Brook 138/69 kV transmission line in Spring 2014. PPL Electric will provide the public notices for this project as required by Section 69.3102 of the Commission's Interim Siting Guidelines, 52 Pa. Code § 69.3102. Further, copies of the filing and notifications of filing will be served in accordance with the provisions of Section 57.74 of the Commission's regulations, 52 Pa. Code § 57.74.

Because the disposition of the Complaint and the approval of the siting and construction of the North Lancaster-Honey Brook 138/69 kV transmission line are interrelated, the consolidation of these proceedings will promote the efficient use of the time and resources of the parties and the Commission. Therefore, PPL Electric respectfully requests that the Complaint continue to be deferred and held in abeyance until such time as PPL Electric submits an appropriate filing to the Pennsylvania Public Utility Commission regarding the proposed North Lancaster-Honey Brook 138/69 kV transmission line. Once the filing for the proposed North Lancaster-Honey Brook 138/69 kV transmission line has been docketed, PPL Electric will timely file a motion to consolidate the Complaint with the filing for purposes of hearings and a decision.

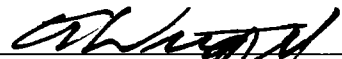
