Transition to Direct Energy in Pennsylvania Talking Points

Why are we changing from Energy America to Direct Energy?

- We are excited about the change!
- The new brand Direct Energy better reflects our service philosophy of allowing customers to "manage" their energy costs- which we supply "directly".
- By transferring our Pennsylvania customers to Direct Energy, the business is building on the brand's success achieved in Canada, Ohio and Texas. Direct Energy has approximately 5 million customer relationships in North America.
- Our customers have made Direct Energy the LARGEST non-utility energy retailer in North America.
- Direct Energy is a part of the Centrica group of companies (as is Energy America). Customers will continue to receive the same excellent service after this change.

Is this change being made because Energy America is having financial problems?

 No. This is a change we have chosen to better reflect our service philosophy and to build on the brand's success in other regions.

Am I required to transfer to Direct Energy?

 You are not required to transfer to Direct Energy if you do not wish to do so. However, requesting that we not transfer your account to Direct Energy will be treated as an early cancellation, and may be subject to a fee depending on your Terms and Conditions of service.

Who is "Direct Energy?"

 Like Energy America, Direct Energy is owned by Centrica plc. Centrica is a leading provider of energy and other essential services. Centrica's North American operations have grown to approximately 5 million customer relationships. Globally, the Centrica group of companies has more than 33 million customer relationships.

Which Energy America customers will be affected by the change to Direct Energy?

 This change affects Energy America's customers in the Columbia Gas of Pennsylvania service territory.

Does the Public Utility Commission approve the change?

- Yes, Direct Energy is licensed to supply natural gas service by the Pennsylvania Public Utility Commission.
- Direct Energy has worked closely with the Pennsylvania Public Utility Commission and Columbia Gas of Pennsylvania regarding the change.

How are customers being notified?

Direct Energy mailed customer notification letters to each Energy America customer.

• The customer notal dion letters were mailed during the last two weeks of October. All customers in Pennsylvania should have received their notice by the beginning of November.

When will the change become effective?

Customers will begin to see Direct Energy listed on their bills starting in January 2005.

What does the customer need to do?

- Nothing! Customers do not need to do anything.
- Direct Energy will honor all terms and conditions of customers existing contracts. As such, new Terms and Conditions will not be mailed.
- Energy America has worked closely with the Public Utility Commission and Columbia of Pennsylvania to ensure the changeover goes smoothly.
- Customers have already received notice of the change through the notification letter Direct
 Energy sent in October. The letter was branded as Direct Energy and had the following
 message on the outside of the envelope, "Important message regarding your Energy America
 natural gas service contract."
- The customers may use the same telephone contact numbers to reach customer service representatives.
- Customers' account numbers will not change.
- Customers will see the new brand beginning with their January 2005 bills from Columbia of Pennsylvania and on all future correspondence from Direct Energy.
- We hope that they will like the new brand!
