

PREHEARING MEMORANDUM OF MIKE KUSTURISS, JR.

To Administrative Law Judge Mary D. Long:

AND NOW, comes the Complainant, Mike Kusturiss, Jr., by his attorney, DAVID BAYARD WOLF, ESQUIRE and KUSTURISS, WOLF & KUSTURISS, and files this Prehearing Memorandum in compliance with the Prehearing Conference Order of January 31, 2014:

I. Presently Identified Issues

Mr. Kusturiss' complaints concern (1) whether or not the Columbia Gas Tariff Rate RSS is unreasonable and discriminatory as applied to him as a property owner with a dual feed configuration, and (2) whether the alleged safety issues concerning dual feed configurations are sufficient to compel Mr. Kusturiss to choose receiving either all or none of his natural gas needs from Columbia Gas.

II. Names and Addresses of Witnesses


Mike Kusturiss, Jr. - Mr. Kusturiss' address is 219 Mosier Road, Eighty Four, Pennsylvania, 15330. Mr. Kusturiss will testify how Columbia Gas' unilateral decision to terminate his natural gas service deprives him of a source of back up gas service

when his own well is insufficient to meet his monthly needs. Mr. Kusturiss will testify that he has always paid his bill on time, and that there have been no issues with his dual feed service. Mr. Kusturiss' direct testimony is expected to take between one quarter and one half hour.

III. Other Matters

Given Columbia Gas' determination to eliminate all dual feed configurations in the Commonwealth as well as the recent *Gaskin* decision, it is unlikely there can be a settlement. Mr. Kusturiss is agreeable to an arrangement whereby his gas service would be maintained for a reasonable period of time until he is able to find an alternative source of back up gas service. Mr. Kusturiss reserves the right to amend this prehearing memorandum to include witnesses depending upon the issues raised at the time of the telephonic hearing.


