

1. Complainant is Joseph Pearson.
2. Respondent is PPL Electric Utilities Corporation (hereafter referred to as "PPL Electric").
3. This Certificate of Satisfaction of Complaint is submitted pursuant to 52 Pa. Code § 5.24(b).
4. PPL Electric hereby certifies that the parties to the above-referenced formal Complaint, now pending before the Pennsylvania Public Utility Commission (hereafter "Commission"), have mutually and voluntarily agreed upon the following terms as full satisfaction of all outstanding legal and factual disputes in this proceeding as to Respondent, PPL Electric, only, and Complainant has acknowledged satisfaction to PPL Electric:
 - (a) Complainant, Joseph Pearson, and Respondent, PPL Electric, agree that Complainant and PPL Electric have entered into a payment arrangement on account number 59280-39057 which has a balance of \$24,337.71. The parties agree that Complainant will make monthly payments on the account in the amount of \$300 by the twenty second (22) day of each month, with the first \$300 payment due on or before


March 22, 2014. If Complainant maintains the payment arrangement, upon the balance reaching \$5,000, PPL Electric will apply a \$5,000 credit to the account, thus reducing the then due balance to \$0.

(b) Complainant agrees to withdraw his Complaint.

5. Respondent, PPL Electric hereby notifies Complainant of the filing of this Certificate of Satisfaction, and that if Complainant objects or disagrees with the terms of the Certificate of Satisfaction, Complainant must notify the Commission in writing of their objection and/or disagreement within ten (10) days of the date this Certificate of Satisfaction was signed and served, or the terms of the Certificate of Satisfaction will become final and binding.


