In the Commission's Order, entered March 2, 2000, at Docket No. A-125072, in Ordering Paragraph 3, the Commission directed the licensee to provide evidence of financial fitness with natural gas distribution companies (NGDCs) to the Commission pursuant to the bonding requirement at 66 Pa C.S. §2208(c).

Since the original Commission Order, Direct Energy Business, LLC (DEB) has revised the list of NGDCs. At this time, the list is as follows:

We are pleased that Direct Energy Business, LLC. ("DEB") has applied for a license to provide Natural Gas Supply Service on the distribution system of Columbia Gas of Pennsylvania, Inc. ("Columbia Gas").

Under Paragraph 2.4.5 of the Rules Applicable to Distribution Service section of the Tariff of Columbia Gas, DEB could be required to provide to Columbia Gas a bond or other financial security instrument in an amount that Columbia Gas determines to be appropriate. We have determined at this time that DEB has met the financial security requirement to provide Natural Gas Supply Service to Columbia Gas customers.

If the creditworthiness requirement or Columbia Gas' exposure to DEB changes in the future, Columbia Gas might deem it appropriate to require DEB to provide a bond or other financial security instrument.

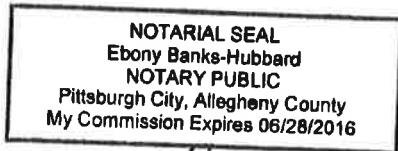


