

SUPPLEMENTAL ORDER

BY THE COMMISSION:

All of the rights granted to Clouse Trucking, Inc., under the certificate of public convenience issued at A-00106830, Folder 1 have been transferred to Carlisle Carrier Corp., at A-00109478 and are now contained under the certificate issued to it.

Clouse Trucking, Inc. holds other authority under a certificate of public convenience issued to it at A-00106830, Folder 2 which it is retaining. A portion of the authority being retained duplicates the authority being transferred; THEREFORE,

IT IS ORDERED: That the first right at A-00106830, Folder 2, be changed to read as follows in order to eliminate any duplication of authority between the rights being transferred and the rights being retained:

To transport, as a Class B carrier, property between points in the borough of Newville and the townships of West Pennsboro, Newton, Upper Mifflin, Lower Mifflin, Penn, Upper Frankford and Lower Frankford, Cumberland County;

subject to the following conditions:

That no right, power or privilege is granted to provide service for Dauphin Distribution Services Co., and The Dial Corporation.

IT IS FURTHER ORDERED: That upon compliance with the conditions and requirements as set forth in the order at A-00109478, all of the operating rights and the certificate of public convenience at A-00106830, Folder 1, be and are hereby cancelled and all rights, powers and privileges granted thereby shall forthwith cease and terminate.
