To whom it may concern:

By letter dated July 28, 1999, Elizabeth J. Fischer, Director of Meeting Services/Tariffs, Pennsylvania Motor Truck Association (PMTA), advised all Public Utility Commission (Commission) certificated household goods carriers participating in PMTA's household goods freight tariffs, that PMTA would be canceling all of PMTA's tariffs effective October 28, 1999.

As of the date of this correspondence, the Commission has not received a new tariff on your behalf, containing rates which would replace the PMTA rates, nor has the Commission received evidence of your participation in the tariffs of another tariff agency which currently has rates on file with this Commission for the transportation of household goods, in use.


It will be necessary that the Commission receive, no later than fifteen (15) days from the date of this correspondence, a tariff which contains rates which are equal to the PMTA rates which were on file with this Commission, or a tariff indicating your participation in the tariffs of a tariff agency which has rates on file with this Commission for the transportation of household goods, in use. Should you decide to file a tariff containing individual rates, rather than participate in a tariff agency's rates, and the proposed rates are higher than those of PMTA, the newly filed rates will be considered a rate increase, and will require financial justification demonstrating that the proposed rates are reasonable and just.

If your household goods authority is not being exercised, and you wish removal of the right(s) which authorizes the transportation of household goods, in use, please contact the Compliance Office, Applications Unit, at (717) 783-5946, for information on how to eliminate the right(s). Should there be any questions regarding the filing of a new tariff, please contact Monroe Dove at (717) 787-5945.

Should you fail to file the necessary tariff within the allotted time, the Commission will institute a complaint, which can result in the cancellation of your certificate of public convenience.





NOTICE OF SUSPENSION OF PUC Truck OPERATING AUTHORITY
Effective 08/07/2011
For expiration/cancellation of
Liability

As of 08/07/2011, your PUC operating authority is **SUSPENDED** due to your failure to maintain evidence of insurance on file with this Commission. **You may not operate while under suspension.** Operating while under suspension is subject to prosecution, which may result in cancellation of your authority.

Your insurer must file appropriate evidence of insurance with the Commission. Appropriate evidence of insurance is a FORM E for bodily injury and property damage liability insurance, a FORM H for cargo liability insurance, or a Surety Bond. These forms must be filed with the PUC by the Insurance Company or Agent, **not by you.** Incomplete forms, incorrect forms and fax transmittals will NOT be accepted. The Commission does permit electronic filing of these forms.

If this Commission does not receive acceptable evidence of insurance within ten (10) days of the suspension date, a Complaint will be instituted against you for failure to comply with this Commission's insurance requirements. The Complaint may result in the cancellation of your PUC operating authority.

If your insurer timely files appropriate evidence of insurance, you will receive Notice from the PUC authorizing you to resume operations. **You may not resume operations until you receive this Notice from the Commission.**

Please notify the Commission if you are no longer in business.
