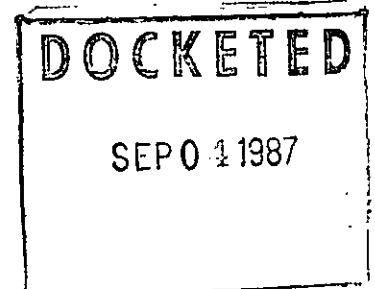


BY THE COMMISSION:

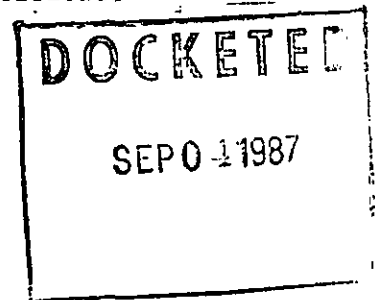

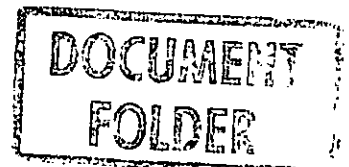
