PUBLIC STATEMENT OF THE
OFFICE OF CONSUMER ADVOCATE
PURSUANT TO 71 P.S. SECTION 309-4(e)

Act 161 of the Pennsylvania General Assembly, 71 P.S. § 309-2, as enacted July 9, 1976, authorizes the Consumer Advocate to represent the interests of consumers before the Pennsylvania Public Utility Commission (PUC or Commission). In accordance with Act 161, and for the following reasons, the Consumer Advocate determined to file an Intervention and participate in proceedings before the Commission involving PPL Electric Utilities Corporation (PPL or Company).

On October 22, 2013, PPL filed Supplement No. 140 to its Tariff Electric – Pa. P.U.C. No. 201 (Supplement No. 140) with the Pennsylvania Public Utility Commission. Supplement No. 140 reflects modifications to the Company's Act 129-2 Compliance Rider (ACR-2), which, according to the Company, is designed to avoid a significant ACR-2 over/undercollection. On December 23, 2013, PP&L Industrial Customer Alliance (PPLICA) filed a Formal Complaint against Supplement No. 140 alleging that Supplement No. 140 constitutes unjust and unreasonable rates under Act 129 and Sections 1301 and 1307 of the Public Utility Code. The Office of Consumer Advocate (OCA) has intervened in this proceeding to review PPL's Supplement No. 140 to ensure that it is just and reasonable, and lawful under the Public Utility Code.
