

C. Issue to be Addressed:

The only issue in this case is the failure by Gholston Paratransit, LLC to ensure that the Commission has on file a valid Form E evidencing adequate liability insurance coverage, in violation of 66 Pa. C.S. § 512 and associated regulations at 52 Pa. Code §32.


D. Evidence to be presented:

I&E will present as evidence Gholston Paratransit's prior valid Form E; the Form K received by Gholston Paratransit's insurance carrier indicating that the insurance coverage expired on January 31, 2013; a notice of suspension letter dated March 8, 2013; and US Postal Service tracking receipts showing that the Complaint in this matter was delivered to Gholston Paratransit, LLC on April 19, 2013.

Additionally, as necessary, the witness will present testimony to any relevant Rosi standards as codified in a statement of policy at 52 Pa. Code §69.1201(c).

E. Settlement:

As of the filing of this Pre-hearing Conference Memorandum, I&E has been *unable to reach Respondent despite numerous attempts via phone and email.* Settlement of this case is not possible, because the Commission still has no Form E on file from Respondent more than a year after its insurance expired. Cancellation of the authority of Gholston Paratransit, LLC is warranted.


