

Under date of April 1, 1999, the Secretary's office transmitted to you the Commission's compliance order adopted March 31, 1999, evidencing approval of the above application which is in effect a transfer of the rights formerly held by Green Transfer & Storage, Inc. at A-00107012. The letter transmitting the order directs attention to the requirements for the filing of a tariff.

Pa. Code, Title 52, Section 23.13(c) provides that in the case of change in ownership, etc., if feasible to do so, the tariffs of the former operator shall be adopted by the new operator, and no changes in rates is permitted to cover the transfer of rights.

In this instance it is not possible to meet the tariff requirements by the adoption of the former tariffs for the reason that the present tariff's description of authority does not conform with the approval of this application.

It will be necessary, therefore, to file a new tariff which should be designated Freight Pa. P.U.C. No.8. The tariff should name the same rates, rules and regulations as were filed by the former operator and may be issued to become effective on one day's notice under authority of Pa. Code, Title 52; Section 23.42.

We notice that rates for a part of the authorized service being transferred are provided in tariffs published by Tristate Household Goods Tariff Conference, Inc., Agent.

IN REPLY PLEASE

If you do not elect to participate in the agency publication(s), a new tariff or tariffs should be filed containing the same rates, rules and regulations currently on file, for a minimum of 30 days.,

There appears in the Pennsylvania Bulletin of December 4, 1999, on page 6210, the notice of an application by Green Transfer and Storage Inc. to discontinue service. The operating rights to be discontinued authorize the transportation of household goods in use between points in the Borough of Ambridge, Beaver County and within an airline distance of ten miles thereof, including the Townships of Harmony and Economy, Beaver County, and from points in said area to points to Pennsylvania, and vice versa.

Please be advised that this operating authority was transferred by the Commission to Debo Moving and Storage Inc. at a public meeting held March 31, 1999 at Docket A = 00106548 Folder 1 - E - July - July - E - E - July -

The Agreement of Sale between Green Transfer and Storage Inc. and Debo Moving and Storage Inc. dated January 22, 1999 provided that all of the operating authority of Green Transfer and Storage, Inc. issued by the PUC was to be transferred to Debo Moving and Storage, Inc. Since the operating rights referred to in the notice have already been transferred to Debo, there would appear to be no cause for a discontinuance application.
