Dear Mr. Pillar:

Under date of June 10, 1998, the Secretary's office transmitted to you the Commission's compliance order adopted June 4, 1998, evidencing approval of the above application which is in effect a transfer of a part of the rights formerly held by Trans American Trucking Service, Inc. at A-00107793, F.2. The letter transmitting the order directs attention to the requirement for the filing of a tariff.

Pa. Code, Title 52, Section 23.13(c) provides that in the case of change of ownership, etc., if feasible to do so, the tariffs of the former operator shall be adopted by the new operator, and no change in rates is permitted to cover the transfer of rights.

In this instance it is not possible to meet the tariff requirements by the adoption of the former tariffs for the reason that the transfer is partial in scope and it is, therefore, necessary to file a new tariff.

The new tariff may be issued to become effective on one day's notice under authority of Pa. Code, Title 52, Section 23.42 and shall be designated Freight Pa. P.U.C. No. 8.
