

RE: Security Requirement for Snyder Brothers, Inc.

Dear David:

Pursuant to 66 Pa. C. S. § 2208 (c), an applicant for a natural gas supplier license in the Commonwealth of Pennsylvania must furnish security to each utility where the supplier will do business to ensure the financial responsibility of such natural gas supplier. To this end, National Fuel Gas Distribution Corporation ("National Fuel") has performed a credit review and analysis of Snyder Brothers, Inc. ("Snyder") and has determined that Snyder must post a security deposit in cash, or a form of security acceptable to National Fuel, to operate as a supplier on National Fuel's system. Therefore, National Fuel will require a security deposit of \$ 200,000.00 (two hundred thousand dollars) in cash, or other form of security as agreed upon by National Fuel and Snyder, before Snyder begins to act as a supplier on National Fuel's system.

National Fuel reserves its right to require Snyder to post security upon reasonable notice. Should you have any questions concerning the above, please contact the undersigned at 716-857-7796.
