
Dear Ms. Adkins:

On March 23, 2001, the Commission issued a license at Docket No. A-125099, authorizing Utility Resource Solutions, LP (URS) the right to begin to offer, render, furnish, or supply natural gas supply services to large commercial, industrial and governmental customers in the service territories of Columbia Gas of Pennsylvania, Inc., UGI Utilities, Inc., PECO Energy Company and PPL Gas Utilities Corporation, within the Commonwealth of Pennsylvania.

On February 26, 2007, URS filed a request that the Commission change the name on its license to provide natural gas supply services from URS to Spark Energy Gas, LP.

Spark Energy Gas, LP has provided proper documentation as required by this Commission.

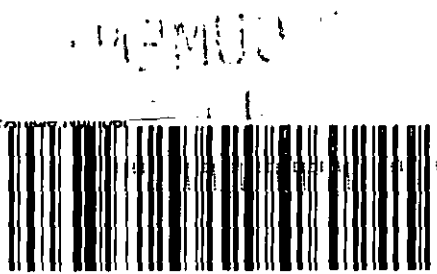


