



Dear Mr. Boyd:

On July 31, 1997, the Commission issued a license at Docket No. A-110025, authorizing Strategic Energy Partners Ltd. (SEP) the right to begin to offer, render, furnish, or supply electric generation supplier services to all customer classes within the Commonwealth of Pennsylvania.

On September 27, 2000, the Commission approved, by Secretarial Letter, the change of the name on its license for the provision of electric generation supplier services from SEP to Strategic Energy L.L.C.

On August 27, 2008, Strategic Energy L.L.C. filed a request that the Commission change the name on its license to provide electric generation supplier services to Direct Energy Business, LLC.

Direct Energy Business, LLC has provided the proper Pennsylvania Department of State documentation and a bond or other approved security as required by this Commission.

Therefore, the Commission approves, by this Secretarial Letter, the change of Strategic Energy L.L.C.'s name on its license for the provision of electric generation supplier services to all customer classes within the Commonwealth of Pennsylvania, at Docket No. A-110025, to Direct Energy Business, LLC.
