
On December 20, 2013 Venskyy Express, LLC changed their insurance company from Progressive to Infinity. After obtaining the insurance policy and being with them and obtaining the proper insurance coverage, Infinity sent us a letter of cancellation on due to the trucks going out of state. After further discussions with an Infinity insurance agent, our cancellation was repealed and our insurance premium raised to account for the changes. Which is proof that Venskyy Express, LLC had insurance coverage the whole time and the original proof of insurance was valid.

Infinity submitted to the Pennsylvania Public Utility Commission (PUC) that Venskyy Express, LLC has received a cancellation notice on their insurance policy, and that their policy will end on January 27, 2014. Venskyy Express, LLC received a letter from PUC stating that it needs to have proof of insurance on. Immediately after receiving this notice, a representative from Venskyy Express, LLC contacted Infinity about the urgent need of proof of insurance that should be sent to PUC. Infinity sent out the proof to PUC on.

PUC rejected the proof of insurance because the name on the policy stated "Andrey Venskyy DBA Venskyy Express, LLC". PUC rejected this proof and did not contact Venskyy Express, LLC or Infinity Insurance until it sent out the public complaint on March 25, 2014 to Venskyy Express, LLC.

All of the changes have been made, by Infinity Insurance, on the proof of insurance forms that they now state "Venskyy Express, LLC" and the corrections. As of right now form "E" proof of insurance was field by Infinity insurance company and form "H" which is cargo insurance was field by Risk Placement Services, Ink.

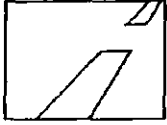

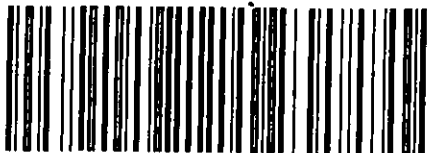

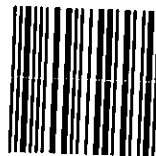
