Respondent, Prestige Limousines, LLC, has paid in full the civil penalty demanded by the Bureau of Investigation and Enforcement ("I&E") to avoid a hearing in the above-docketed proceeding. On April 17, 2014, the Commission received a payment of \$1,500, bringing the total civil penalty paid to \$2,500. Prestige also made a refund payment in the amount of \$2,127. The Parties amicably agree that this civil penalty and refund satisfy the above-docketed complaint.

Accordingly, pursuant to 52 Pa. Code Section 5.24(a), I&E files this letter to certify that the above-docketed proceeding has been satisfied and should be marked closed. As such, I&E requests that the hearing scheduled to be held before Administrative Law Judge Joel Cheskis on Tuesday, April 29, 2014, as well as all associated directives set forth in the ALJ's Prehearing Order, be cancelled.
