BY THE COMMISSION:



Upon review of the request, it appears that the necessary filings have been made and that there has been no change in the ownership or control of the business; THEREFORE, IT IS ORDERED:

1. That the request is approved and that the certificate issued to Independent Freightway, Inc., t/d/b/a be changed to stand in the name of Landstar Inway, Inc.
